Report: Recruitment of Independent Chair

Purpose of Report

To propose the option of recruiting an independent Chair for the Surrey Hills AONB Board

Summary

Following the May elections, there has been a change in all 5 of the borough and district Member representatives on the Surrey Hills AONB Board. This has included the loss of the Chairman and Vice-Chairman who were elected at the AONB Board's AGM on 12th September 2018.

In order to ensure a level of continuity in the future, officers propose that the AONB Board now seeks an Independent Chair. It is proposed that this is for a period of three years. The appointment of an independent (non-political) Chair is common amongst other AONB partnerships and National Park Authorities. It is allowed within the terms of the existing Constitution and the Chair's role (Appendix 1) was agreed at the AONB Board on 12th October 2016.

It is proposed that a Panel is established to review and interview, as necessary, the candidates and to make a recommendation to the AONB Board's AGM in September. The AONB Board should be comprised of the SCC Member (as the accountable body for the Joint Committee), a borough and district member, and a representative of the Surrey Hills family (Surrey Hills Enterprises, Trust Fund and Society). Officers will prepare the terms of reference for the panel, the materials for prospective candidates, the criteria against which to assess candidates, the questions that would be put to candidates and the mechanism for agreeing the candidate to be recommended to the Board. Appendix 1

Chair of the Surrey Hills AONB Board

This is a voluntary role, but reasonable expenses will be claimable, based on Surrey County Council's rates of payment.

Main Purpose of Role

To provide leadership and strategic direction to the Surrey Hills AONB Board and the activities of the Surrey Hills Family.

Principal Duties and Responsibilities

To chair meetings of the AONB Board and Statutory Members Group and to guide the AONB Director on the agenda and approach to meetings.

To provide advice and guidance to the AONB Director and staff team

To champion the interests of the Surrey Hills AONB and build support for the aims and priorities of the AONB Management Plan and for the work of the Surrey Hills AONB Family.

To foster supportive and inclusive partnerships in support of the work of the AONB, building mutually beneficial relationships with all interested bodies working in the countryside.

To ensure effective cooperation between the Surrey Hills AONB Board and the constituent members of the Surrey Hills Family.

- To assist in maintaining an appropriate relationship with the host local authority, balancing the benefits of integration with the interests of all partners and with the need for the Board, the Family and the Partnership to maintain their autonomy.
- To represent the AONB Board in a variety of networks (local, regional and national); to participate in activities of the National Association for AONBs, including the annual general meeting.
- To take an active interest in the work of the AONB Board, including staff members and Working Groups.
- To maintain an understanding of the issues facing the AONB and to undertake such training and seminars as may be necessary.

To fulfil these duties in a manner that is free from political bias and influence.

To encourage AONB Board Members to act in the interests of the Surrey Hills AONB

- 3. Sustainable farming and land management practices are critical to the management of the AONB landscape. How can you influence a future UK agricultural policy and arrangements that might benefit the Surrey Hills?
- 5. The Surrey Hills relies on effective partnership, particularly the collaboration between the AONB Board and the Surrey Hills Enterprises CIC, the Surrey Hills Society and the Surrey Hills Trust Fund, which is held within the Community Foundation for Surrey. How would you ensure greater collaboration to the benefit of the Surrey Hills and each member of the family?
- 6. Influencing individuals and organisations, including local authorities, to take account of the AONB is a key aspect of the role. Can you outline the important organisations, boards and individuals that you would engage as a priority in the first six months and how you would go about this?
